### RULES OF THE AUCTION & PHONE BIDDING

- o All phone bidders must be signed up at least two (2) weeks prior to each auction.
- o All phone bid registrations must have a valid credit card on file in order to participate in the auction. This does not mean that we will use that card for payment if you win. Upon winning an item, you may choose how to make your payment.
- o The descriptions and information for the auction items are presented by the Eastern Chapter of the Wild Sheep Foundation (EC WSF) in good faith; however, EC WSF does not warranty or assume any liability for the accuracy or completeness of the depiction of any item presented for auction. The donor has provided the values placed on all auction items. EC WSF has no responsibility or control over the values submitted.
- o It shall be the responsibility of the purchaser or winner of any Canadian trip to pay the Government Service Tax (GST) levied by the Canadian Government.
- o The auctioneer has final authority on the amount paid for any item and the identity of the purchaser of any item.
- o It shall be the responsibility of the purchaser to contact the outfitter to confirm the dates of the trip, obtain licenses and arrange for reservations and accommodations.
- o EC WSF accepts VISA, MasterCard or personal check. A 3.5% surcharge will be levied for credit card payments.
- o All firearms purchased or won at the convention shall be shipped to a Federal Firearms License (FFL) holder of the purchaser or winner's choice. The purchaser or winner of a firearm will be responsible for the cost of shipping.
- o EC WSF does not and may not offer or provide any warrant or certification that a purchase made at the live or silent auctions is eligible for any federal or state tax deduction. It is recommended that the purchaser or winner's accountant verify any consideration of tax exemption or deduction.
- o The EC WSF Board of Directors reserves the right to reject or accept any bid from our auctions.
