2024 EXHIBITOR TERMS AND CONDITIONS

- Eastern Chapter of the Wild Sheep Foundation (ECWSF) reserves the right to alter booth assignments at any time due to layout re-design or for even distribution of exhibitors. If this is necessary, you will be notified.
- All items, including booth structure, props and signs, may not extend past the 10' x 10' booth space. This is a safety issue and you will be asked to remove offending items or consolidate your booth space if this is a problem.
- ECWSF asks that you consider other exhibitors with regard to your booth layout by keeping noise, audio/visual equipment, or any other objects that may interfere with another exhibitors space at minimal levels.
- Any additional equipment (i.e., lighting, electrical, internet) must be arranged prior to the show. Any incurred charges will be at your expense.
- **Set-up is Thursday from 7am to 5pm and Friday from 7am to 11am. You may tear down and leave Saturday night after 8pm. ALL EXHIBITORS must be torn down and out of exhibit hall by 10 am on Sunday. Your cooperation is vital.**
- Food/beverage samples and the sale of pre-packaged food items are acceptable.
- Food Preparation/Cooking: Food may not be cooked or prepared at the LCCC Facility without; (1) the prior written permission of the LCCC and (2) the proper permits. All approved food preparation must be completed in accordance with the instructions and guidelines provided by LCCC.
- Only alcohol sold on site is permitted in vendor hall.
- ECWSF reserves the right to request an exhibitor to leave before or during the convention if any of the terms are not upheld.
- There will be no fundraising activities allowed in any booth without the prior approval from ECWSF.
- No exhibitor shall share, assign, or sublet their booth space or any part of the space assigned. Only goods or services that are offered during your regular course of business may be exhibited or offered.
- ECWSF, its directors, employees, volunteers, and/or members are not responsible for any property or bodily injuries, including but not limited to death, that occurs or is implied to have occurred at the 2024 EXPO held at the Wyndham Resort in Lancaster, PA
- Exhibitor will not be given access to booth (s) until full payment is received by ECWSF. Booths are not assigned until payment is received.
